






Pursuing "District" Accreditation

 - Governing authority all county BOH's

District Strengths

- Supportive BOHs.
- Understanding of the benefits of accreditation.
- Clear understanding of the difference between QA and QI.
- Dedicated district and county staff and leadership.
- Initiative to complete the PHAB online training and familiarize team with PHAB website.

Common Barriers

- Lack of funding to support fees.
- Continued need for technical assistance.
- Lack of time and resources to complete prerequisites.
- Lack of personnel dedicated 100% to accreditation efforts.
- Lack of integrated health information systems.

Why Pursue State Accreditation?

- Provides focus for DPH
- Provides framework for decision making
- Aligns activities to match strategies and priorities
- Plans activities to achieve maximum public benefits
- Helps explain what we do & why we do it
- Helps evaluate performance
- Continuous Quality Improvement
- Links to "Good to Great"

State Timeline

- Distribute DPH Public Health System Assessment survey
- Forces of Change discussion
- Present CHA to DPH for final comment and approval

January – June 2016

- Complete CHIP
- Present CHIP to public and key stakeholders
- Finalize Documentation collection

July 2016

- All Prerequisites Complete (CHA, CHIP, SP)
- •Complete Documentation Collection
