Performs family planning services including complete gynecological exams, clinical breast exams, and screenings and diagnostic tests according to protocol. Education, counseling, dispensing, and surveillance of contraceptive methods including but not limited to oral contraceptive methods, injectables, placement and removal of intrauterine devices, and contraceptive implants. Travel within the district based on clients needs.

JOB RESPONSIBILITIES:

1. Administers or orders diagnostic tests, such as x-ray, electrocardiogram, and laboratory tests.
2. Develops comprehensive plans of care.
3. Examines clients to obtain information about their physical condition.
4. Instructs and counsels clients about prescribed therapeutic regimens, normal growth and development, family planning, emotional problems of daily living, and health maintenance.
5. Interprets diagnostic test results for deviations from normal.
6. Makes tentative diagnoses and decisions about management and treatment of clients.
7. Obtains compiles and records client medical data, including health history, progress notes and results of physical examination.
8. Performs therapeutic procedures, such as injections, immunizations, suturing and wound care, and infection management.
9. Prescribes therapy or medication with physician approval.
10. Visits and observes clients on hospital rounds or house calls, updating charts, ordering therapy, and reporting back to physician.
11. May supervise support and/or lower level employees.
