2019 MEETING MINUTES

Georgia Public Health Association 90th Annual Meeting and Conference Business Session

The business session for the 90th Annual Meeting and Conference of the Georgia Public Health Association was called to order by President Colin Smith on Tuesday, May 7, 2019, at the Westin Buckhead, Atlanta, Ga. Board Secretary Cindi Hart and Membership Chair Sally Silbermann confirmed a quorum was present.

Board Secretary Cindi Hart presented the Credentials Report. The total number of persons registered for the beginning session of the 90th Annual Meeting and Conference of the Georgia Public Health Association was 540. The credentials report was adopted.

President Elect Chris Rustin presented the 90th Annual Meeting and Conference Program for adoption. Jessica Pavlick made the motion and Amber Erickson seconded the motion. The program was adopted.

Board Secretary Cindi Hart entered the minutes into the record and moved to adopt the minutes of the 2019 Georgia Public Health Association business session. The minutes of the 2019 business session were accepted as read and will be filed in the Georgia Public Health Association's official records.

Board Treasurer Candace Christian presented and moved for adoption of the Finance Committee Report of the Georgia Public Health Association Fiscal Year Ending June 30, 2018, Financial Report on Page 19 of the 90th Annual Meeting & Conference Program. Total Assets \$174,698.01, Total Liabilities and Net Assets \$174,698.0. Motion seconded by Amber Erickson. The financial report was adopted.

The GPHA Annual Audit ending June 30, 2018, is in the final steps of be completed by an independent auditor, Hill, Wingate, and James. The audit will be placed on the GPHA website for review.

Sally Silbermann the membership chair presented the membership report. We have 540 registered for the conference. 763 general membership, 7 retired members, 66 honoree members, 289 Career Development Members, 1008 Boards of Health and 35 organizational memberships and has a total membership of 2,168.



2019 MEETING MINUTES

The slate of officers received from the Nominating Committee and approved by the Georgia Public Health Association Executive Committee, were presented to the membership by President-Elect Dr. Lawton Davis. Nominees were President-Elect, Chris Rustin; Vice President, Saroyi Morris; Secretary, Cindi Hart; Treasurer, Morris Hutcheson; American Public Health Association Representative, Jimmie Smith. In accordance with the Bylaws the President-Elect Dr. Lawton Davis will ascend to the Office of President and Vice President Chris Rustin will ascend to the Office of President-Elect at the conclusion of the 90th Annual Meeting and Conference. There being no further nominations from the floor, the slate was accepted by acclamation.

Yvette Daniels on behalf of the bylaw committee will move for the acceptance of the revision to Article V Sections Section1 to effectively re-word the bylaws to change primary health care and rural health to primary healthcare and rural health section. This was seconded by Candice Christian. The edit to the bylaw is accepted.

Following remarks to the attendees, current President Colin Smith passed the gavel onto the Georgia Public Health Association 2019-2020 President, Dr. Lawton Davis, who offered remarks and adjourned the meeting.

Date: August 18, 2021

While APHA is the national voice on public health, it could not succeed without the complementary efforts of its Affiliates. Since 1918, APHA's 53 state and regional public health associations have championed the same goals as APHA to promote, protect and advocate for the public's health. As the Georgia affiliate, we are independently established and have their own infrastructure, policies, processes, and procedures. We participate, implement, and advocate on behalf of various public health issues through our annual meeting, program development, continuing education, professional development, and advocating on behalf of good state public health policy and legislation.

The strategic priorities of APHA are built around its vision to create the healthiest nation in one generation. The three overarching priorities are to 1) ensure the right to health and health care, 2) create health equity, and 3) build public health infrastructure and capacity. As *Generation Public Health* is a movement of people, communities and organizations, a set of initial, measurable metrics to give us snapshots of our progress toward creating the healthiest nation have been established. They include:

- Life Expectancy- Increase life expectancy; Increase healthy life expectancy at birth.
- **Education** Increase on-time high school graduation (domestically) and increase high school graduation rate (internationally)
- **Healthy Communities** Reduce firearm-related deaths, increase social and emotional support, increase proportion of adults with good or better mental health, increase proportion of adults with good or better physical health (domestically); Reduce assault by firearm, increase social vs. health



care spending, increase having someone to rely on in time of need, improve happiness (general satisfaction with life) (internationally)

- Income Mobility- Increase number of persons living above federal poverty level
- **Food and Nutrition** Increase the number of children and adults to a healthy weight (BMI 18-24.99)
- Environments- Improve air quality by reducing the number of days Air Quality Index exceeds 100 (weighted) and (internationally) Reduce greenhouse gas emissions, Reduce CO2 emissions
- Healthy Behavior and Choices- Increase non-smoking adults to 88%
- **Health Care** Increase access to physical, mental, and oral health care to 100 percent (proportion with medical insurance), 49 percent (proportion who use oral health care system)

Georgia remains an active member of the Council of Affiliates, and in 2019, I was selected to represent Region IV within the Council of Affiliates. Region IV includes North Carolina, South Carolina, Tennessee, Florida, Mississippi, Alabama, Kentucky, and Georgia. This additional duty includes attending monthly CoA meetings and keeping the ARGCs in Region IV informed of APHA activities. These activities have included promoting trainings in advocacy and leadership, participating in the mid-year meeting of the Governing Council, actively participating on one of the CoA committees, attending and participating in all Governing Council sessions during the APHA Annual Meeting. As these trainings are shared with APHA members electronically, I will not re-list them in this summary, but they can be accessed at www.apha.org.

As your ARGC, I have actively participated in all aspects of APHA as required and per Georgia Public Health Association Bylaws. I did fully participate in the 2020 Annual Meeting Governing Council sessions utilizing the virtual format. In early 2021, members of the Governing Council voted to attend the 2021 APHA Annual Meeting, in person. I am registered for this conference and do plan to attend in person unless APHA advises the Governing Council to amend the plans.

Dr. Judith Monroe, president and CEO of the CDC Foundation, has dedicated hercareer to protecting people and saving lives. She joined the CDC Foundation in February 2016 as president and CEO, following her role as a deputy director of the U.S. Centers for Disease Control and Prevention (CDC) and director of CDC'sOffice of State, Tribal, Local and Territorial Support.

In her work at the CDC Foundation, Dr. Monroe advances priority programs thatimprove the health of people across America and around the world. The CDC Foundation mobilizes philanthropic and private-sector resources to support CDC'scritical health protection work, managing hundreds of programs in the United States and in more than 140 countries.

The CDC Foundation is actively supporting CDC and U.S. health departments' response to the COVID-19 pandemic and support to low- and middle-income countries. Under Dr. Monroe's leadership, the CDC Foundation has provided support to disproportionately affected populations; procured personal protection equipment for frontline health workers; hired over a 1,000 surge staff for all 50 states, six large cities, tribal organizations and territories; supported data solutions for contact tracing. In addition, the CDC Foundation is supporting communications and clinical research, including a portfolio with a focus on health equity. The CDC Foundation is providing technical assistance and grants to community-based organizations to assure vaccine accessand partnering with cross-sectoral leaders to provide expert panel discussions and scenario planning to help safely reopen the U.S. economy.

The CDC Foundation responded to the Zika epidemic as an implementing partner in addition to mobilizing resources; supported the response and recovery from the 2017 hurricane season; and serves as a strategic partner to CDC for global health security.

Prior to the CDC Foundation, Dr. Monroe oversaw key activities and technical assistance at CDC supporting the nation's health departments and the public health system. Throughout the 2014–15 Ebola epidemic she served as senior advisor for the domestic response. During her tenure as the state health commissioner for Indiana she servedas president of the Association of State and Territorial Health Officials through the H1N1 pandemic. She envisioned and founded the ASTHO president's challenge in 2008. This leadership platform resulted in initiatives with significanthealth improvements and focus of ASTHO annual meetings.

Dr. Monroe currently serves on the board of directors for the Center for Global Health Innovation, was appointedby Governor Holcomb to co-chair a public health commission for Indiana, is a member of the Milken Institute's Public Health Advisory Board, the COVID Collaborative, the Advisory Council of the Pandemic Action Network andthe APHA Alliance for Disease Prevention and Response. Additionally, she served as a member of the World Health Organization Foundation's Advisory group to establish the WHO Foundation.

Among her many awards, Dr. Monroe was recognized in August 2021 as one of Atlanta's Most Admired CEOs for 2021 by the *Atlanta Business Chronicle*; in October 2020 she was awarded the United Way of



Greater Atlanta with the Woman of Excellence Award for her unwavering commitment to serving the community; and in 2019 shereceived the Metro Atlanta Chamber of Commerce MAC Heroes of Global Health award and the APHA PresidentialCitation. CDC's Office of Minority Health and Health Equity also recognized her in 2020 as their Summer Health Equity Champion. And, in 2019, she received the American Public Health Association's Presidential Citation for herwork to improve the health and wellbeing of people around the world, and for her commitment to the future of public health as a mentor to young physicians and public health students.

Dr. Monroe received her doctor of medicine from the University of Maryland and a bachelor of science degree fromEastern Kentucky University. She completed her residency in family medicine at the University of Cincinnati, a rural faculty development fellowship through East Tennessee State University, and a minifellowship in obstetrics throughthe University of Wisconsin. She also participated in the State Health Leadership Initiative at Harvard University's Kennedy School of Government and received an honorary doctorate from Purdue University in Health and Human Services.

GPHA AWARDS AND AWARD RECIPIENTS

It takes the extraordinary effort of many to build healthier communities in Georgia and encourage everyone to invest in public health. GPHA would like to take this opportunity to recognize the outstanding service of just a few of those during this year's Annual Meeting and Conference.

DESCRIPTION OF AWARDS

Fred Agel Governance Award

The Fred Agel Governance Award is a Boards of Health Section award to recognize outstanding commitment and service in the promotion of public health.

Administration Outstanding Service Award

The Administrative Section Outstanding Service Award was first given in 2013. This award is presented to someone who has demonstrated exceptional public service by enhancing the fiscal and administrative areas in support of providing public health services to the community.

Applied Epidemiologist of the Year Award

The Applied Epidemiologist of the Year is an annual award for outstanding contributions to the field of applied epidemiology. This award recognizes one applied epidemiologist each year for contributions that resulted in translating epidemiologic evidence to clinical, public health, or health policy applications within the state of Georgia.

Stancliff Boone Communicable Disease Specialist Award

The Stancliff Boone Communicable Disease Specialist Award is an annual award for outstanding contributions to the critical work done by communicable disease specialist. This award recognizes one communicable disease specialist for contributions that resulted in positive disease intervention activities within the state of Georgia. This award is named to honor both Janet Stancliff, who worked efficiently and effectively to promote the collection of critical data by epidemiologists statewide for the state STD office, and Ronald Boone, who worked as a communicable disease specialist for the North Central Health District in Macon, GA for 25 years and was an active member of the Epidemiology Section of the Georgia Public Health Association throughout his tenure with public health.

J. Patrick O'Neal Safety & Health Preparedness Award

The J. Patrick O'Neal Georgia Public Health Association Safety and Health Preparedness Section Award was established in 2018 in honor of Dr. J. Patrick O'Neal who served as



Commissioner and Director for Health Protection at the Georgia Department of Public Health (DPH) where he had oversight responsibility for Emergency Medical Services (EMS), Trauma, Emergency Preparedness, Epidemiology, Infectious Disease, Immunizations, and Environmental Health. The annual award is to be presented to an individual who has contributed to the work of Emergency Preparedness and Response to recognize outstanding commitment and service in the promotion of public health safety and preparedness.

Nutrition Outstanding Leadership Award

The Nutrition Section of the GPHA proposes a new award to recognize members' achievements, determination, and efforts. The Outstanding Leadership Award seeks to distinguish Nutrition Support Staff who have consistently shown dedication to their work and have supported others with guidance and positive attitude. It is the second award proposed by the Nutrition Section—the first award being The Rosemarie Newman Nutrition Award which pursues to acknowledge those whose contributions resulted in improved outcomes to individuals or families in the community. Unlike the Rosemarie Newman Award, The Outstanding Leadership Award focuses on one individual whose contributions have helped promote growth within their program by continuously demonstrating leadership skills. The award also aims to bring attention to individuals whose work often goes without recognition yet enhances the program's achievement. Nutrition Supportive Staff are vital for organizations' success; therefore, it is crucial to acknowledge their diligence and commitment.

Rosemarie B. Newman Nutrition Extra Mile Award

The Rosemarie B. Newman Nutrition Extra Mile Award was established to recognize outstanding achievements in the area of nutrition.

Georgia Dental Award of Merit

Initiated in 1989, the Georgia Dental Public Health Award is presented to an individual or organization by the Georgia Department of Public Health Oral Health Section and the Georgia Public Health Association Medical-Dental Section for outstanding services and contributions to the Georgia Dental Public Health Program nationally, regionally, statewide, and/or locally.

Larry W. Miller Health Information Specialist Award

The Health Information Specialist of the Year Award began in 1998 and is presented to a member of the Information Technology Section. The Health Information Specialist of the Year Award was established to recognize individuals for their professional contributions to managing, analyzing, producing, and communicating health information.

Kathy Miner Health Education & Promotion Award

The Kathy Miner Award was established to recognize outstanding achievements in the area of health education and promotion.



Lillian D. Wald Public Health Nursing Award

The Lillian D. Wald Public Health Nursing Leadership Award honors the memory of Lillian Wald, the founder of American Community Nursing. She was known as an advocate for the poor and a human rights activist who founded the Henry Street Settlement in New York City in 1893, which changed the model for public health care delivery in New York. She advocated for nurses in public schools and coined the term "public health nurse" to describe nurses whose work is integrated into the public community. The purpose of this award is to recognize demonstrated initiative and resourcefulness in developing efforts to improve the health of the public through advocacy by way of political, legislative, professional or interdisciplinary collaboration.

Maggie Kline Nursing Award

The Maggie Kline Nursing Award was established in 1989 to honor Maggie Kline who, for several years, coordinated the continuing education program for public health nurses in Georgia. Maggie was committed to ensuring that nurses were provided ongoing education and training to utilize best practices in their delivery of services to clients and to develop the associated skills necessary to do so. This award is specifically designed to recognize a new comer to public health nursing who demonstrates: excellence in the execution of public health programs or services, creative or innovative approaches to practices that results in improved utilization of public health programs and services, and exemplary nursing practice that employs the use of individual and population-based care.

Barfield Nursing Award

The Barfield Nursing Section Award was initiated by the Nursing Section of the Georgia Public Health Association in 1983 to honor Dorothy Barfield. Ms. Barfield was a lifelong learner who rose up the ranks in the nursing profession, eventually serving as chief nurse at the state level. The purpose of this award is to recognize written works, presentations or projects, including research, that promote public health by contributing to public health issues, programs, evidence and philosophies.

Ruth B. Freeman Award for Population Health Practice

The Ruth B. Freeman award was established to honor Ruth B. Freeman, who provided standards for the nursing profession, standardized nursing practice, and advocated for the further education and educational equality of nurses by insisting that nurses have the same status and curriculum as physicians and other professionals in public health degree programs. In doing so, Ruth B. Freeman contributed to the legitimization of nurses as equitable members of the healthcare team. This award is specifically designed to recognize a public health nurse who engages the use of evidence-based practices to develop and deliver public health interventions to high-risk groups and individuals through data mining, community health assessment, and engagement and mobilization of coalitions and partnerships. This nurse demonstrates the use analytical models to determine and present outcomes of interventions and uses outcomes to advocate for population groups within the community, recommend public health policy, and/or enforce health statutes and regulation.



FRED AGEL GOVERNANCE AWARD

Carol S. Holtz, RN, PhD



Dr. Carol Holtz, professor emeritus of nursing at Kennesaw State University retired in August, 2018 after 38 years of working as a nursing faculty member. She received her Bachelor's Degree in Nursing from the University of Cincinnati, her Master's Degree in Nursing from Georgia State University, and her PhD in Nursing also from Georgia State University. At KSU she taught nursing in all three programs, which included Bachelor's, Master's and Doctorate degree programs. In addition, she taught nursing at Del Mar College in Corpus Christi, Texas. Prior to teaching, Dr. Holtz worked as a staff nurse at Cincinnati General Hospital (now called University Hospital), in Cincinnati, Ohio, Emory University Hospital in Atlanta, Ga., Memorial Medical Center in Corpus Christi, Texas, and St John's Hospital in Tulsa, Oklahoma.

Since leaving KSU, Dr. Holtz continued to keep her position as Chair of the Cobb County Board of Health, as well as Chair of the Cobb County Community Services Board (serving mental health, drug abuse and children and adults with

developmental delays). She is also one of six community members who serve on Cobb County's Congregation Etz Chaim Synagogue Medical Advisory Board. Dr. Holtz was selected as one of 15 LIVESAFE Resources Women of Achievement Nominees for Cobb County women for 2019.

Her husband of 53 years, Dr. Noel Holtz, a neurologist, and their 13 grandchildren, all reside in Atlanta, Ga. Dr. Holtz just completed the 4th edition of her textbook, *Global Healthcare*, published by Jones and Bartlett publishers of Boston, MA. Dr. Holtz has a passion for traveling. While teaching at KSU, she developed and taught a study abroad program in Oaxaca, Mexico for 22 consecutive years, and continues to travel there, now taking her husband and grandchildren, as well as going with other faculty members. She is a very active member of the International Transcultural Nursing Society, having been an associate editor of their *Journal of Transcultural Nursing*, and working in a smaller specially selected "scholar's group". She also actively participates in Sigma Theta Tau nursing honor society. Her future plans include continued international travel with family and also with KSU retired faculty, and to continue as chair of the Cobb County Board of Health and the Cobb Community Services Board.



ADMINISTRATION OUTSTANDING SERVICE AWARD

Dr. Randy McCall



Dr. Randy McCall started his public health career in 1989 in Environmental Health at the Camden County Health Department. In 1999, he became Program Manager for the Coastal Health District and then in 2009, he took on the role of Administrator for the Chatham County Health Department. As Administrator, Dr. McCall oversees all programs (Clinical, Environmental Health, and Vital Records) and the day-to-day operations of two health department locations and more than 100 employees.

Many progressive and innovative things have taken place in Chatham County under his leadership. He oversaw the demolition of the old health department on Eisenhower Drive which had been in existence since the 1940s and subsequent construction of a new LEED (Leadership in Energy and Environmental Design) certified Health Department. Not long

after construction of the new health department on one side of town, Dr. McCall supervised the complete renovation of the second Chatham County Health Department location in downtown Savannah which took over a year. He did all this in a fiscally responsible manner, ensuring that all work was completed on time and on budget.

Katrina works tirelessly to ensure that STD and HIV services are available throughout six counties which include two large hospital systems, Winn Army Hospital (healthcare provider for Fort Stewart and Hunter Army Airfield), King's Bay Naval Submarine Base, two Community Health Centers, and a host of correctional facilities.

She has developed and maintained positive relationships throughout her coverage area, particularly with hospitals and agencies that provide services to the homeless population. Katrina works with many community partners and is well known as an STD/HIV expert.

As an HIV testing trainer, Katrina works with new staff to make sure they are trained and proficient with rapid testing technologies. When we have a newly diagnosed client, she works directly with a Linkage Coordinator to get the client into care. Katrina also works with the Prevention Team to plan HIV testing events around HIV Awareness Days and serves as the main resource for county public health nurses regarding HIV/STD services.

As the lead CDS, Katrina oversees Quality Improvement activities and deliverables for the STD Program. She is the champion for correctly filling out field and interview records and proper closure of cases and assists the CDS supervisor with case reviews and other trainings.

Katrina is passionate and driven to improve the lives of people in her community and is a perfect example of public health at its best.

NUTRITION OUTSTANDING LEADERSHIP AWARD

Julianne Gaston, IBCLC



Julianne Gaston is a consummate nutrition professional with expertise in system processes and pediatric nutrition. Julianne has been a Registered Dietitian Nutritionist for 40 years with the last 30 years providing nutrition services to the citizens of Georgia in many capacities. Julianne worked with the Grady Hospital System in Georgia in her early Georgia Career. Her focus was on the HIV program and assured WIC benefits for these children with special needs. Julianne provided case management services for the children related to nutrition support along with full nutrition assessment, counseling, and education. Her work enabled children to survive a life-threatening disease for longer periods than might occur without her intervention.

In 2011, Julianne came to work with the Georgia WIC program at the state level. She brought her detailed eye to improve policies, practices, and procedures within Georgia WIC. Through her work

the Georgia WIC Risk Criteria have been consistently implemented per WIC regulations across our 4 front end computer systems and 1 data management system. She has been able to regularly assure the data sent to our funder related to specific risks like obesity and prematurity is reported accurately. She has identified ways to modify monitoring systems for Georgia WIC procedures and practices at the front lines so that Georgia WIC is consistently improving the nutrition care provided to applicants and participants. She provides training in updated nutrition procedures especially related to nutrition data entry in ways that take a complex subject and make it understandable and relatable. She is currently assigned to the Georgia WIC Management Information System and eWIC (electronic benefits) project while providing support to the monitoring team. She is a repository of knowledge at the intersections of operational and nutritional implementation of the WIC program in Georgia.

Julianne has always been willing to step up and provide support when the Nutrition Program needed support in areas beyond her usual job duties. At times she provided leadership for the Georgia Department of Public Health Dietetic Internship program when the Director unexpectedly left the program. She has stepped in to provide leadership for the Georgia WIC Online Nutrition Education program when staff assigned to the work have left. She has worked as one of two staff nutritionists at the State Level prior to restructuring increased the staffing level to better meet the needs. She has guided many state level nutritionists to successful work within Georgia DPH. Many of these nutritionists are still working for Georgia DPH providing excellence in service to the Georgia WIC program.

GEORGIA DENTAL AWARD OF MERIT

Pam Cushenan, RDH, MS, FSCDH

Community Outreach is a recognized passion of Pam Cushenan. She has participated in outreach efforts since becoming a dental hygienist in 1987 in the United States and abroad. As a dental hygiene educator, she is dedicated to facilitating collaborative community-based efforts that improve the welfare of underserved communities in Georgia.

In the last two years alone, she has continued to dedicate her time to initiate proposals, create tailored programs for multiple underserved population sites, and engage dental hygiene students to enhance their cultural competency.

In April 2018, Georgia State University's (GSU) Assistant Director of Development Bill Covington reached out to Gas South's Community Affairs Program Manager Carley Stephens to discuss collaborative opportunities in the community. Gas South partners with Norton Park Elementary School, a Title I school in Smyrna, GA. Bill reached out to the GSU Perimeter's Dental Hygiene Department for assistance to positively impact the children's welfare and Pam Cushenan created a proposal to meet this request that focused on oral health education and preventive services.

Pam has developed relationships with multiple underserved community organizations for student interaction. These include Adult Day of Dunwoody (older adult care setting), Covenant House (shelter for 17-21-year-olds), Nicholas House (family shelter), Survivors of Head and Neck Cancer at Emory, a domestic violence shelter, disabled American veterans, and a refugee center. Pam guides students through assessments, planning, implementation, and evaluation of oral health education and screening programs with low-cost or free dental referrals provided to attendees. The students gain great insight from these experiences and share their outreach reflections with other student team members. Pam is also the Community Service Chair for the Dental Hygiene Department. As such, she connects the students with community service requests from across Georgia and oversees the student preparation, implementation, and reflection of each experience.

In the last two years, Georgia State University Perimeter College community outreach events have served 4477 children, teens, adults, and older adults in Georgia. Pam also volunteers in other outreach events, such as the 2019 Moultrie Migrant Family and Farm Worker collaborative event where hundreds of children received education and preventive dental services and farm workers received education, screenings, and referrals, as needed.

Finally, Pam is a strong advocate for change. She teaches her students how to be a change agent on all levels, including the legislative level. Students become well-versed in the legislative process, discover their district leaders, and meet with their legislators at the Capitol. She also served in the Georgia Dental Hygienist's Association as the Advocacy Chair and helped to pass a recent bill that increases access to oral care in Georgia.

Pam remains focused on developing and maintaining a health and wellbeing presence in all settings to include dental hygiene students, grads, licensed professionals, community settings, and collaborative parties. Her goal is to increase the number of skilled providers working as health teams in the community to maximize the wellbeing of vulnerable populations.

Rebecca began her career in public health in 2010 as the lead PCM and prenatal nurse at the Richmond County Health Department. Wanting to expand her knowledge of all programs in public health, she transitioned to the Sexually Transmitted Infection clinic where she went on to become the STD Coordinator and clinic supervisor. During her tenure as STD Coordinator, she saw clients come into the clinic who did not have symptoms but liked to be tested regularly. At the time, there was no precedent or protocol that supported not performing exams every time a client was tested. This sparked her desire to find a way to provide

this needed service but also allow the nurses to see more clients who were symptomatic. After much research, she wrote the Fast Track Policies and Procedures which allow trained CDS staff to conduct a brief interview to determine eligibility for the service and to test clients for HIV, syphilis, gonorrhea, chlamydia, and trichomonas without the client needing to see a nurse. After several drafts and many collaborative meetings, the policies and procedures were approved by DPH for use. Rebecca then went on to supervise the South Augusta branch of the Richmond County Health Department and shortly thereafter, she became the Nurse Manager of both sites. During her time as the Nurse Manager, she successfully made changes to the way nurses were trained and to clinic flow. She was and continues to be part of the team that started the Centering Prenatal Program at the Richmond County Health Department. In December of 2019, Rebecca became the Women's Health, BCCP, and STD Coordinator for the East Central Health District (6).
