Weekly Legislative Report #12

Week Ending April 4, 2025

There are few phrases as welcomed under the Gold Dome as “*adjourned sine die*” . . . especially when it’s approaching 1:00 a.m. at the end of the 40th legislative day as it typically does each year. However, members and long-time lobbyists alike were shocked when the Senate Majority Leader moved to adjourn the First Session of the 158th Georgia General Assembly Friday evening sine die at 9:11 p.m. Each chamber had not long before taken a dinner break, and after taking in nourishment, both the House and Senate settled into a routine that was expected to last until midnight or even later. Rep. Alan Powell was presenting his school camera bill on the House Floor when he realized the Senate had abruptly adjourned. It was soon determined that any action taken by the House to amend a bill would not get Senate action until the 2026 session.

The House was determined to fight on as Speaker Burns said, “We’re working for the people of Georgia. You can go home if you want to.” Nevertheless, the House adjourned sine die at 10:37 p.m. Rep. Gerald Greene, Dean of the House with 43 years of service, said he could not remember anything quite like this ending to the session.

Please find below some of the highlights of what did and did not make it across the finish line. We have already reported on the tort reform package ([SB 68](#) and [SB 69](#)) passing the House and Senate in prior weeks, which Governor Kemp unequivocally named his number one legislative priority for the 2025 legislative session. We are sure bill signing ceremonies will soon be announced.

FY 2026 Budget

The House and Senate met its constitutional obligation by adopting [the FY 2026 budget](#) – a \$37.7 billion budget that prioritizes spending on education and prisons.

The budget conferees approved Governor Kemp’s recommendation to fully fund the new private school voucher program with \$141 million. About 10,000 students have applied for vouchers, although the program doesn’t begin until July. The budget also includes \$300 million to fully fund the state’s Quality Basic Education K-12 student funding formula. It contains \$108.9 million in state grants to help local school systems pay for safety improvements on their school campuses, which will provide each school with \$47,124. Another \$19.6 million is earmarked for a new program called “student support services,” which will include mental-health counselors for the schools, and \$15.3 million will go to support economically disadvantaged students through a one-

time pilot program. The school-safety and mental-health services funding are in response to the school shooting at Apalachee High School in Barrow County last September. Also in the education arena, the budget provides \$18.5 million to hire 116 literacy coaches who will work to improve reading scores.

Lawmakers have made conditions inside Georgia prisons a top concern. The [FY 2026 spending plan](#), increases spending for the Georgia Department of Corrections by \$200 million, \$75 million above what Governor Kemp recommended in the budget he presented to the General Assembly in January. That \$200 million spending increase for the prison system includes \$13.4 million to give correctional officers 4% pay raises and \$45 million to hire an additional 700 guards to better protect inmates by lowering the inmate-to-staff ratios. Another \$34.2 million is allocated for repairing deteriorating prison infrastructure.

The budget conferees were able to draw down additional funds for education and prisons at the 11th hour, when Governor Kemp raised his revenue estimate for fiscal year 2026 this week by \$50.4 million. The budget also includes \$16.9 million to increase reimbursement rates for providers serving Medicaid patients and \$7.4 million for graduate medical education to help address shortages of health-care providers, particularly in rural Georgia.

Other spending items include \$500,000 for state planning contracts at regional commissions, \$1.09 million for Home and Community Based Services, increased funding for the Alzheimer's and dementia related registry and funding for two additional training instructors at the Public Safety Training Center focusing on those with Alzheimer's disease.

School Speed Cameras - Dead

There were two school speed camera bills, [HB 225](#) and [HB 651](#). Both passed the House, both passed the Senate as Committee Substitutes and then both were sent back to the House for final action. However, when it was all said and done, there was much said and nothing done. The House did not take action on HB 225, which called for a total ban on the devices. Rep. Alan Powell was in the midst of persuading his House colleagues to amend HB 651 when the Senate adjourned. Bottom line, there will be no changes to Georgia's school speed camera law this year. However, it's a sure bet the issue will be on the agenda when the 2026 session rolls around.

Election Law Bill - Dead

The election bill, [HB 397](#), would have withdrawn Georgia from a voter registration organization, and banned absentee ballot drop offs the weekend before Election Day. It originally passed the House, and the Senate by committee substitute. The Senate returned it to the House for final action; however, final action never happened.

Diversity, Equity and Inclusion – Dead

Another bill that made it through the Senate, but died in the House was DEI legislation. The House did not take action on this legislation, but it will be eligible for consideration next session.

Bills Governor Kemp is Likely to Sign

It is expected that the Governor will sign a bill that bans transgender girls and women from playing women's sports from grade school through college. And, a bill to block gender affirming care for state prison inmates.

Bills Governor Kemp will Certainly Sign -- Tax Refund and Relief

Georgia taxpayers will pay a little less after Governor Kemp signs two tax relief measures following their approval by the House and Senate. "The final passage of these two measures today brings us one step closer to eliminating the state income tax, while providing tax relief for Georgia families and businesses," said Lt. Governor Burt Jones, who thanked Governor Kemp for leading the effort. [HB 112](#), which passed unanimously, seeks to give one-time rebates equaling \$250 to single tax return filers, \$375 to heads of household and \$500 to married couples filing jointly.

[HB 111](#) will reduce Georgia's income tax rate from 5.39% to 5.19% retroactive to the beginning of the current tax year. Sen. Elena Parent, D-Atlanta, said it amounts to \$10 off the taxes for earners in the bottom 20% but at least \$3,000 for the top 1%. "You won't pay a dime in state income tax unless you make over fortyish thousand a year," said Senator Bo Hatchett, R-Cornelia, adding that he'd like to see the state income tax eliminated altogether.

Governor Kemp signs RFRA Bill

Governor Kemp signed religious freedom legislation last Friday aimed at preventing government intrusion into Georgians' rights to exercise their religious beliefs. The bill closely tracks a federal RFRA law Congress passed back in 1993. Governor Kemp said the RFRA bill builds on past efforts targeting discrimination in Georgia, including a hate-crimes law the General Assembly passed following the murder of African American jogger Ahmaud Arbery near Brunswick by two white men in 2020 and last year's bill aimed at antisemitism. RFRA has been championed for years in the legislature by Sen. Ed Setzler, R-Acworth, unsuccessfully until this year's session.

Next 40 Days

Governor Kemp has 40 days following adjournment sine die (May 14) to sign or veto bills, or they become law without his signature. Georgia Governors also enjoy the authority to veto line items in the budget bill. Very rarely does a Governor allow a bill to become law without his signature, but it does happen on occasion, so it's best to "never say never" when predicting the action or inaction of our political friends.
